ELIGIBILITY REQUIREMENTS

1. The Jack Deibert Memorial Scholarship is available for students currently enrolled in college as a student (*taking at least 6 credit hours*) or for High School Seniors planning to attend college.
2. **All majors qualify.** Please enclose most recent transcript
3. The applicant **must be a member in good standing** with BMI Federal Credit Union.
4. Board of Directors, Management, Staff of BMI Federal Credit Union, their immediate family members, and previous winners of the Jack Deibert Memorial Scholarship are not eligible.

ESSAY REQUIREMENTS

- a. Must include a title page containing the following information
 - *Essay Title, Student's Name, Student's Address and Phone Number*
- b. Your essay must be typed in 12-point size type and double spaced on 8-1/2" x 11" white paper with one-inch margins on all sides. The text of your essay should be no more than three pages excluding title page

SELECTION CRITERIA

The Selection Committee will base the selection of the scholarship recipients on the following:

1. Application: (35 points)

- Community service, volunteer work, and/or extracurricular activities. (1-10 points)
- Honors, awards, recognitions and/or leadership achievements (1-10 points)
- Education/career goals and how scholarship will help you in obtaining these goals (1-10 points)
- Compliance with required format (1-5 points)

2. Essay: (65 points)

- Quality of essay (1 - 50 points)
- Grammar, punctuation, spelling and neatness (1-10 points)
- Compliance with required format (1-5 points)
